

**GREATER LAVA HOT SPRINGS CHAMBER OF COMMERCE**  
**MEMBERSHIP RATES for 2022**

**Membership Levels**

- **Individual (non-business) or Non-profit.** No vote or board position: \$100
- **Primary Business Membership** (Includes voice, vote and website/brochure listing.)
  - Level 1 Self Employed and No Employees \$150
  - Level 2 (Up to 5 FTE) \$250
  - Level 3 (6 -15 FTE) \$300
  - Level 4 (16 or more FTE) \$350

**One Primary Business Membership = One Listing**

One primary business membership equals one listing in one category on the Chamber website and one category on the Chamber brochure. A member who has **more than one business at the same physical location** with fewer FT employees than their main listing will be allowed up to two (2) **additional listings** for those other businesses at the following reduced rates:

\$100 per “each” additional listing. (The additional listing will be in one category on the Chamber website and one category on the Chamber brochure) **No voice or vote with additional listings.**

**How to Calculate Number of Full Time Employees(FTE):**

Number of employees is calculated by adding the “total” number of hours paid to “all” employees during the year, then divide that number by 52 and divide that answer by 40. The final answer is the number of FT employees.

**First Time Primary Business Membership Incentive:**

As an incentive to first time primary business memberships, a one-time introductory dues rate reduction of 30% will be given if the new member joins prior to February 1<sup>st</sup> of each year. **A returning membership is not eligible for a first-time membership incentive.** An existing member who opens a new membership for a business that has never held a Chamber membership is eligible for the incentive for that new membership, but not for his or her existing membership(s). Additionally, “new members” joining the Chamber after April 1<sup>st</sup> of any year will receive a prorated quarterly discount. The discount shall be no more than 50% of the annual dues rate.

- Example: New member joins after April 1<sup>st</sup> and before July 1st. (discount is 25% of annual dues rate.)  
**Member may not be listed on the current Chamber brochure if it has already been printed. Member “will” be listed on the Chamber website.**
- All new memberships paid after July 1st will be 50% of the annual dues rate. **Member may not be listed on the current Chamber brochure. Member “will” be listed on the Chamber website.**
